<ul style="list-style-type: none"><li>The import/export permit will incur a fee of \$100.00 per stallion per shipment per owner.</li><li>From the 2018/2019 season all stallions standing at stud by frozen semen for public use must follow the nomination protocol and supply genetic testing status or proof of clear by parentage.</li><li>All stallions for which frozen semen is imported must follow the same regulations as if he is being imported himself.</li></ul>

## DNA Information

- The cost of DNA-typing is included in the Registration Fee for Purebred Colts and Fillies (*see Registration Fees*).
- All Purebred Arabian Stallions and Mares used for breeding must be DNA-typed prior to breeding.
- All Purebred Arabians that were Blood-typed must now be DNA-typed.
- All Purebred Arabian Foals born after 1 August 2002 must be DNA-typed and Parent Verified at Registration. In the case of Purebred Arabian Geldings, hair must be collected and supplied to NZAHS in the DNA-typing Envelope at the time of Registration and will be held in storage in case it is required at a later date. There is no charge for Gelding envelopes issued to be held in storage.
- All Purebred Arabian Foals produced using imported semen must be DNA-typed and Parent Verified at Registration (including Geldings who shall be required to pay a DNA-typing fee in addition to the Registration Fee).
- DNA-typing is not required for Derivative registrations.
- DNA-typing must be completed prior to export for all Purebred & Derivative horses (including Geldings). Contact the Secretary to obtain a DNA envelope and costs.

### Collecting Hair for DNA Typing

- Pull mane hair from above the wither (from mid neck region).
- Firmly grasp a tuft of 25-40 hairs as close to the skin as possible and pull evenly and directly away from the neck. The aim is to pull the hairs out by the roots rather than breaking off the hairs. When you look closely at the ends you will be able to see the small roots (especially with a magnifying glass). At least half of the hairs should have roots.
- Avoid contaminating with hair from other horses. Collected hair should be immediately placed in the labelled envelope, sealed (avoid licking) and posted inside another envelope to the NZAHS Office.

<ul style="list-style-type: none"> <li>• Registrations for Purebred Arabian horses will only be accepted from current Full or Junior Full Members.</li> <li>• Registrations for Purebred Arabian horses must be applied for by 1 July in season of birth. Late fees are applicable after this date.</li> <li>• Registration can be held in the case of a Colt if the breeder is undecided whether to geld or not. This registration will be held until 1 November in season of birth, at which time either a gelding certificate is provided or full registration fee for a Colt is paid. Contact the Secretary for details.</li> <li>• As of 1 August 2015, the Colt registration fee has been reduced and is a set fee, no gelding refund shall be payable if the Colt is subsequently gelded.</li> </ul>		

<b>Derivative Arabians</b> ( <i>contact the Secretary for "Application for Registration" Forms</i> )

<ul style="list-style-type: none"> <li>• The breeder or person registering a Derivative or Anglo-Arabian Horse must be a Full or Associate member of the NZAHS.</li> <li>• Derivative &amp; Anglo-Arabian Horses <b>DO NOT</b> need to be Branded, Microchipped, DNA typed or their markings signed off by a qualified veterinarian for the purpose of registration.</li> <li>• Arabian Derivatives registered from 1 January 2012 shall contain not less than 12.5% Arabian blood. It is the responsibility of the breeder to provide proof of pedigree back to the Purebred Arabian blood line for nonregistered NZAHS horses that contribute to the Arabian percentage. Such lines must be unbroken and all ponies/horses must be registered with a recognised Society for applications to be eligible. Proof of pedigree shall be in the form of copies of registration certificates or stud book entries for all ponies/horses back to the Purebred Arabian blood line.</li> <li>• Anglo-Arabian registrations must be accompanied by details of the Thoroughbred parent's registered name, DOB, name of Sire &amp; Dam.</li> <li>• If the person submitting the application is not the breeder, a signed transfer form &amp; transfer fee must accompany the application.</li> </ul>
