#### **SCID, LFS & CA REQUIREMENTS FOR PUREBRED STALLIONS & COLTS**

- 1) All Arabian stallions or colts which are to stand at Public Stud for the coming season **MUST** have carrier test results for SCID, CA & LFS recorded with the NZAHS in order to be nominated for use at Public Stud from 1 August 2019. Stallion or colt owners **MUST** advise the NZAHS if genetic test results are to be withheld from publication.
- 2) **\*\*** All Arabian stallions or colts to be bred from **MUST** have carrier test results for SCID, CA & LFS recorded with the NZAHS in order to be nominated for use at Stud from 1 August 2019. This is only if the stallions or colts used to serve Arabian mares or fillies are **NOT** owned or leased by the owner or lessee of the stallion at the time of service. Stallion or colt owners **MUST** advise the NZAHS if genetic test results are to be withheld from publication.
- 3) NB: Regardless of the method of breeding used, colts and fillies must be at least 24 months of age prior to their use for breeding. It is the recommendation of Council that fillies are not bred before 36 months of age.
